D. FOREIGN POLICY IS A RESPONSIBILITY OF THE PRESIDENT AND SECRETARY OF STATE. THE MILITARY IS AN INSTRUMENT OF FOREIGN POLICY AND NOT A MAKER OF FOREIGN POLICY. ALL MILITARY PERSONNEL WILL REFRAIN FROM COMMENTING ON OR SPECULATING ABOUT FOREIGN POLICY MATTERS, EXCEPT TO ACCURATELY REFLECT WHAT THE PRESIDENT OR SECRETARY OF STATE HAVE ENUNCIATED.

ON 11 JUNE 1967 NEWS MEDIA REPRESENTATIVES EMBARKED ABOARD AMERICA WERE PERMITTED TO INTERVIEW CTSN KENNETH ECKER B513648/USN A CREW-MAN OF USS LIBERTY RECOVERING ABOARD AMERICA FROM WOUNDS RECEIVED IN THE RECENT ISRAELI ATTACK AND CDR. J.J. GORDON MC USN AMERICA MEDICAL OFFICER. THE INTERVIEW WAS REQUESTED BY NEWS MEDIA REPRESENTA-TIVES. PRESENT AT THE INTERVIEW WERE: ROBERT GORALSKI OF NBC, HARRY STATHOS OF UPI REPORTING UNDER THE PSEUDONYM OF JAMES STAFFORD FOR CBS RADIO, HELMUT SORGE OF DER SPIEGEL, GENE SHERMAN OF COPLEY NEWS SERVICE, D.C. TRENARY OF MILWAUKEE JOURNAL, BOB HORTON OF AP AND WILLIAM GILL OF ABC. THE INTERVIEW WAS NOT FILMED BY TV MEDIA REPRESENTATIVES BUT WAS RECORDED IN PART BY CBS RADIO. PUBLIC AFFAIRS OFFICER AMERICA HAS A TAPED RECORDING OF THE INTERVIEW WHICH WILL BE FORWARDED UPON REQUEST.
- 2. SEAMAN ECKER WAS BRIEFED IAW REF A AND B. CLEARED BY THE MEDICAL OFFICER WHO SIGNED A STATEMENT AGREEING TO THE INTERVIEW. AMERICA PUBLIC AFFAIRS OFFICER MONITORED THE INTERVIEW. ECKER WAS INTRODUCED AS A RADIOMAN ABOARD LIBERTY.
- 3. WHILE NOT REQUIRED THIS REPORT SUBMITTED IAW REF (C) P3-73 OF THE SENSITIVE NATURE OF THE LIBERTY INCIDENT.
- 4. THE INTERVIEW DEALT WHICH [WITH] ECKER'S EXPERIENCES DURING THE ISRAEL ATTACK. HE WAS ASKED TO RECOUNT IN DETAIL HIS OWN ACTIONS DURING THE ATTACK. MUCH ATTENTION HAD BEEN FOCUSED ON HIM BECAUSE OF HIS BATTLE HELMET, WHICH HE RETAINS. THE HELMET HAS BEEN CREDITED WITH SAVING HIS LIFE. IT HAS SEVERAL SHRAPNELL HOLES AND A PART OF ONE ROUND REMAINING LODGED IN THE HELMET AT A POSITION NEAR THE TEMPLE
- 5. NO UNEXPECTED PROBLEM AREAS WERE ENCOUNTERED IN THE INTERVIEW. AT ONE POINT, WHEN ASKED OF THE GENERAL FEELING AMONG LIBERTY CREWMEN AS THEY SPENT THE NIGHT IN DISTRESS, ECKER ANSWERED RATHER PASSIONATELY QUOTE WE WANTED TO GET THEM SONS OF BITCHES WHOEVER ATTACKED US UNQUOTE. WHEN PRESSED FOR THE FEELING AFTER IT BECAME KNOWN THAT THE ATTACKERS WERE ISRAELIS, ECKER REPLIED AFTER QUOTE WE STILL WANTED TO GET THEM. WE DIDN'T CARE WHETHER THEY WERE FRIENDS OR ENEMIES. THEY HIT OUR SHIP AND WE WANTED TO MAKE THEM PAY UNQUOTE.

#### 'I Am Just Glad To Be Alive'

## Wounded LIBERTY Crewman Ecker Tells Of Attack

crewmen of the stricken U.S. Navy communications ship, USS LIBERTY (AGTR-5), Seaman Kenneth Ecker, 18, answered questions of newsmen of the national press during an interview aboard USS AMERICA (CVA-66) on June 11. The interview covered Seaman Ecker's actions and observations during the mistaken attack upon the LIB-ERTY by Israeli forces on June 8 which cost the lives of 34 men.

Seaman Ecker, fatigued but alert, responded with sullen reflection as he described the events of the attack he had experienced. Ecker, of Wateska, Ill., reported aboard the LIBERTY in March 1967. He is striking for radarman.

The LIBERTY sailor told newsmen he was on the s' 's fantail when the a ick began. "I looked up and a plane was coming right over the bow with his guns blazing," he recalled.

"I headed for my general quarters station...I got my helment, my life jacket and put down a hatch and got ready to follow instructions from the damage control officer."

Ecker, assigned as bearer during stretcher general quarters, was soon called to the bridge, an area of the ship under heavy aircraft attack. Jpon reaching the bridge, he found that a lieutenant was crippled by a leg wound and was unable to

"He was in the passageway and wanted to be loved to a stateroom so he ould get out of the way of fire parties. Me and her fellow picked him ip and put him in a rack .nd just as I was going to eave the stateroom I got it in the back of the ead," Ecker said.

Ecker was struck by shrapnel in the head and neck. During his interview aboard AMERICA, he sat cross-legged, exhibiting in his lap the helment he had worn during the attack. The helment was pierced and dented in several places, testifying to the force of the metal that pelleted Ecker. Abrasions and scratches trailed down his neck, but the fiercest blow was blunted by the steel helment and produced a large wound on the back of his head.

Asked by newsmen if the helment had been the factor that saved his

"It was pretty calm," he reflected upon the sickbay's activities during the attack. "No one panicked on the whole ship from what I saw and from what I heard from other men. Everyone did their job like they were supposed to. That is what saved the ship."

After a torpedo struck the ship, LIBERTY's crew prepared to abandon ship. Coming above decks to report to his abandon ship station, Ecker observed three torpedo boats steaming approximately 100 yards off the LIBERTY's life, Ecker emphatically stern. He could not resaid, "Yes." cognize the nationality of

hours later, after returning to sickbay, that the torpedo boats and aircraft were Israeli. The fact was received in the LIBER-TY's radioroom over British Broadcasting Company program.


'That night, before we were evacuated, many of the men who hadn't been wounded came around giving us shots," Ecker said. "We only had two corpsmen and one of them had been shot; but he was aiding the wounded and several of the unwounded were coming around making us more comfortable and giving us the shots. One of the best shots I've had so far was by one of the men back on the ship. He was a corpsman."

On June 9, the charred and listing communications ship, with a twisted and shattered superstructure, was along side AMERICA. Ecker and his wounded shipmates were transferred aboard AMERICA to be treated. The radarman and his helment were brought aboard the carrier in one of AMERICA's helicopters.

At the interview, newsman asked, "What are you going to do with your helment with the holes in

"I am going to keep it," replied Ecker, fondly gripping the helment. "Nobody is getting that."

Aftereffects? Ecker admitted to the press that he still had a slight headache but "other than that I am just glad to be alive."



#### **DAVIS FAMILYGRAM 4-67**

As you can easily guess from watching TV newscasts, listening to the radio and reading newspapers, the past few weeks have been extremely busy for those of us assigned to the U.S. Six Fleet.

Our Atlantic transit, beginning in Newport on 2 May and ending at Gibraltar 10 May, was busy but relatively routine. We had a full scheduled of exercises, refuelings and individual training drills. All of this training has stood us in good stead, as the tempo of operations picked up noticeably after our departure from Gibraltar. We had a sort but enjoyable stop in Gibraltar, not realizing at the time that it was to be our only port for over a month!

We operated as a unit of the Sixth Fleet, increasing our readiness as the Middle East crisis increased in intensity. We continued to enhance our overall capability by participating in exercises involving antisubmarine warfare, anti-air warfare, seamanship, navigation, engineering, damage control, communications and all the myraid of complex skills that it takes to form a smoothly operating, effective man-of-war.

Late on the afternoon of June 8, while steaming with our task force, word was received that USS LIBERTY (AGTR 5) had been strafed and torpedoes off the coast of Egypt. These accidental attacks had been conducted by Israeli forces, and had left LIBERTY with over 30 dead, approximately 75 wounded and listing heavily to starboard. Captain H.O. Leahy, Commander Destroyer Squadron TWELVE, embarked in DAVIS, was directed to proceed to the scene with DAVIS and USS MASSEY (DD 778) to render assistance.

DAVIS and MASSEY rendezvoused with LIBERTY at 6:00 A.M. June 9, following a run of twelve hours in excess of 30 knots. Both ships immediately put their motor whaleboats in the water with medical and damage control personnel. After

they had boarded LIBERTY, DAVIS went directly alongside. About 100 of our crew went aboard to render all assistance possible. We helped to remove the dead and wounded to helicopters, restored electrical power, started to shore-up bulkheads in the vicinity of the torpedo hole, gave the survivors hot food and coffee and assisted in many other ways. When we cleared her side three hours later, we left four officers and sixteen men aboard to help bring the stricken ship into port.

LCDR. William PETTYJOHN, Chief Staff Officer for COMDESRON TWELVE, stayed aboard LIBERTY as acting Executive Officer. Lt. John UTZ, Squadron Medical Officer, also remained aboard. Lt Paul Tobin and ENS Dave BREUER remained to supervise emergency damage control and repair efforts. Also assisting to bring LIBERTY into port were: EMCS Robert P. DICKEY, BTCS William F. MASON, PN1 John P. CONROY, EMC Linton J. COATNEY, DC1 Raymond T. RICHARDS, HM1 Anker I. MATHISEN HM2 John W. LIBBY, SM3 David CARMICHAEL, SN Daniel O'NEIL, SN Alton GRIFFIN, SN William MURRAY, SN Robert FEIT, SA Thomas DUNN, EM1 Max BAKER, EM3 Stanley ZAMBER, EMFN Larry BROYLES and EM3 Raeburn POST.

During the five day transit to MALTA these men from DAVIS remained aboard LIBERTY, either filling in for her dead and injured or performing highly complex damage control and engineering repair functions to keep LIBERTY afloat and moving toward her destination. The fleet tug PAPAGO accompained us, available for towing assistance is required. In my own opinion, it was the magnificent efforts of the DAVIS crew that allowed LIBERTY to reach port without further damage. Also deeply involved in assisting LIBERTY were our radio gang, since she had lost almost all communications capability. We acted as LIBERTY's ears and voice until our departure from MALTA June 19. Much credit goes to Lt Glenn SMIT, LTJG John FARRELL, RM1 Guilford PERRY, RM2 Kenneth INGRAM, RM3 Richard TANGUAY, just to name a few.

I was very proud of the entire crew during this tragic period and have written letters of Commendations for the Officers and men who were most directly involved.

We escorted LIBERTY into MALTA at daylight June 14 and remained their until the 19<sup>th</sup>. We had an enjoyable five day visit, although it was necessary to spend a great deal of time and effort in shipboard maintenance after 30 days of grueling operations. As usual, conduct ashore by the entire crew was exemplary. The weather was excellent throughout the visit and we were all able to relax a bit ashore.

Hopefully, the Middle-East will stay cooled off, our future schedule will not be as intensive and we will get to visit some of the more interesting and colorful ports of the Mediterranean.

Of more immediate interest to many of you, the schedule ASW modernization of DAVIS has been delayed. We were scheduled to be decommissioned on November 1 for this modernization. At this stage, I have no information on the length of delay nor on future employment of the ship, after our scheduled return to Newport about 22 September. I imagine that the delay will be for several months, but we will inform everyone as soon as more is known.

Our mail has been coming through frequently, but don't stop now! Mail is the single, most important morale factor when we are deployed - so remember, WRITE to your loved one in DAVIS.

#### Annex I

#### News Media Coverage

When news of the LIBERTY attack reached the Pentagon, CINCUSNAVEUR was advised by telephone that Deputy Secretary of Defense VANCE had directed that all news releases would be made at the Washington level.

At midday on 8 June 1967, the Department of Defense announced that a U. S. Navy technical research ship, the USS LIBERTY, had been attacked at about 0900 EDT that day. The release reported LIBERTY's movements for the preceding two days and stated the ship's purpose for being positioned 15 miles north of the Sinai Peninsula was to assure communications between U. S. government posts in the Middle East and to assist in relaying information concerning the evacuation of U. S. dependents and other U. S. citizens from the Arab-Israeli war area. Ship's characteristics and personnel allowance were included in the announcement. The story was published that evening in the late-edition newspapers with little deviation from the DOD release.

Morning editions on 9 June carried essentially the same story reported the previous evening. The Washington Post carried an additional story concerning use of the hot line to inform Moscow that U. S. Sixth Fleet aircraft were being scrambled to protect a U. S. ship which was under attack. That evening, late editions began to hint that LIBERTY was used for electronic snooping. Such speculation was undoubtedly prompted by an Associated Press story of 9 June "Aboard the Carrier America" by Bob HORTON which stated that an officer had said, "to put it bluntly, she was in there to spy for us. Russia does the same thing. We moved in close to monitor the communications of both Egypt and Israel. We have to. We must be informed of what's going on in a master of minutes." The USS AMERICA claimed that the alleged statement quoted by Mr. HORTON was not based on any contact with an official spokesman nor was it attributable to any of AMERICA's officers. AMERICA expressed the belief that the copy was not transmitted via naval communications and that it probably was sent ashore by COD flight which departed AMERICA for Athens at 091030Z.

Newspapers on 10 June seized upon the snooper story and thereafter speculation was rampant concerning the LIBERTY mission. An aggravating influence was an honest account in the Baltimore Sun concerning the death of Allen M. BLUE which identified him as an NSA employee.

Three official press interviews were conducted aboard AMERICA: four walking wounded LIBERTY crew members were interviewed on 9 June; SN Kenneth P. ECKER, another injured crewman, on the 11th; COMSIXTHFLT, VADN W. I. MARTIN, held a press conference on the 15th subsequent to his visit to the LIBERTY. The ECKER interview was widely publicized on 12 June, most newspapers giving it human-interest treatment, stressing that ECKER's life was saved because he was wearing a steel helmet.

Beginning 12 June, newspapers carried the story of LIBERTY's progress en route Malta and gave extensive coverage to the ship's arrival there on the 14th. Photographs of external damage appeared and reports attributed to crewmen were published, claiming that the attack was not accidental and that the ship had been reconnoitered by the Israelis prior to the attack.

On 16 June, syndicated columnist Drew PEARSON wrote that the LIBERTY was a CTA ship.

was a CIA ship.

An article by George WILSON in the Washington <u>Post</u> on 18 June stated that "NSA was running things in the bowels of the ship." WILSON erroneously described the functions of most of LIBERTY's antennas.

The Washington Post, on the 20th quoted a story from an Arab newspaper which charged that LIBERTY took active part in the fighting on the side of the Israelis.

On 28 June, DOD released a summary of the proceedings of the U.S. Navy Court of Inquiry which investigated the circumstances surrounding the attack on LIBERTY. The same day the text of a letter from crew member SA Robert REILLY to his mother, giving a colorful account of the attack, was published in the Navy Times.

The 6 July issue of the Washington Post included a letter to the editor from Admiral George W. ANDERSON, USN (Ret.), former CNO, which took exception to the Post editorial of 30 June entitled "Not Good Enough." (See Appendix I.) The letter pointed out that the editorial failed to acknowledge that operating forces are assigned to unified commands and joint agencies which would not in this case be under command of the Navy. Also, that communications channels involved no longer are under control of the Navy but, often, and in this case did, pass through non-naval links; thus, LIBERTY paid part of the cost of excessive centralization. The admiral's final remarks were that the important point which should have been emphasized by the editorial was that LIBERTY definitely was operating in international waters and was attacked without provocation, in violation of any valid concept of international law, and, further, that the editorial itself was "not good enough."

From mid-July until her arrival in Norfolk, Virginia, on 29 July, LIBERTY passed from the news scene. Her return to the U. S. sparked renewed press interest as reflected by a long article in the Norfolk Virginian-Pilot on 30 July, the James J. KILPATRICK write-up in the Washington Star on 1 August and a short item in the August 9th issue of the Navy Times.

A seven-page article, "June 8, at 1400 hours", by James Jackson KILPATRICK, appeared in the 5 September issue of the <u>National Review</u>. The story is based largely on the summary of proceedings of the Navy Court of Inquiry released to the press. KILPATRICK has many unanswered questions which he states "nag for answers."
